Agenda Item #2 - Enrollment update and feedback from the field:

Felicia Vertin reported:

1000 Your Healthcare Plus patients have been enrolled in the Behavioral Health intervention to date

Her team reports that the patients are generally appreciative and have called at times of crisis

Her team has also outreached to 50 community mental health organizations. They are scheduling meeting times to discuss cooperative efforts

One of the challenges seems to be a lack of psychiatrists to see Medicaid clients Much discussion around this fact -

Reported that 50 out of 102 counties in IL have no psychiatrists

Leigh Steiner had previously done a needs assessment strategy

Low reimbursement was mentioned as a barrier

Strategies to increase PCP management of behavioral health clients

Step Care Algorithms

Availability of telepsychiatry consultations

Increased use of Psychiatry residents for patient care

Look into loan repayment schemes

Suggest retention strategies to keep them after graduation Potential use of Psychiatric Nurse Practitioners in consumer care

ACTION ITEMS:

Irene Pierce volunteered to get further information on reimbursement issues for NPs Meryl Sosa volunteered to quantify how many psychiatry residents there were in IL HFS is working with many groups on telepsychiatry and payment issues

Agenda Item #3 – CNS mailing and update:

2336 letters were mailed to providers in mid-November
They covered 5909 distinct patients
44% dealt with the use of psychotropic medications
41% dealt with benzodiazepines
41% dealt with multiple prescribers
So far they have received 107 responses (4%)
Usual response rate is 10%
33% of responses were "not my patient"

This usually means an error on the pharmacy side in provider name capture Second mailing will be going out 12/18/06 with same cover letter

CNS, McKesson, and HFS to investigate "not my patient" responses at the claims level Same groups to discuss any problems/complaints about Do Not Mail lists Cover letter wording to be revised and highlighted for January mailing CNS to incorporate group suggestions and present revised letter at next meeting

Agenda Item #4 - Review of Schizophrenia and Depression Clinical Indicators

Suzanne Andriukaitis explained the components and evidence behind psychoeducation Rod Matticks noted that smoking cessation is associated with changes in the metabolism of many psychotropic medications, and this needs to be monitored Peter Alahi had questions about how the PHQ-9 is administered and where results go General discussion about techniques to improve adherence

Agenda Item #6 – Medical Co-morbidities

Reviewed the NASMHPD data and cited other evidence about increased incidence as well as poorer outcomes in groups with serious mental health disorders Group felt education of providers and consumers was key gap to fill Better communication needed between behavioral health and medical providers Pharmacies are also areas under-equipped to deal with multiple med interactions "Confidentiality myth" needs to be addressed
